*I have been asked for a general response to the media portrayal of Mary and myself over the past few days. These are my general feelings at present:*

If any rational person had the same experience with the media, particularly television media, that I have had, they would find it more difficult to believe that the media tells the truth, than they would to believe that I am telling the truth.

The only person in the media thus far who has accurately and honestly reported without sensationalism anything to do with Mary or myself, our life, or the life of people who have been listening to us, has been Eloise Handley of the South Burnett Times, our local newspaper. Unfortunately though, even the local newspaper is resorting to modifying my photograph in order to create a story. We are personally amazed by the extent of media misrepresentation.

All other journalists, radio hosts, and TV personalities with whom we have had dealings thus far misrepresent the truth about ourselves and what we present beyond recognition. In many cases, in particular the case of Channel 7, they have misrepresented and lied purposely in order to inflame the public. Video clips are persistently presented without context or consideration of truth, words are resolutely misquoted and purposefully misrepresented, our personal net worth is inflated 1000's of times beyond all recognition, and it is claimed we own property we do not own. The determined efforts to resort to sensationalism and bias for their own financial and professional "benefit" are beyond ridiculous. Any rational answers we give to rational questions are cut and removed from most media presentations.

Mr David Millikan, the Channel 7 interviewer, has not openly disclosed the actual events relating to the collection of interview material. There were no Channel 7 hidden cameras as claimed by Channel 7; there is no "compound", no one else besides us stays permanently on our property. Mr Millikan knows I make no claim to be God, but allows suggestions from so-called "cult experts" that I am doing so in his programme. He is presenting his own personal opinions in order to support his own Christian belief systems (that Jesus is God), and often completely distorts the truth about Mary and my personal life, as he well knows, in order to obtain his underlying goals.

Unfortunately most of the public is not aware that almost all video material presented by the media is video material that I have created and freely given, and placed on DVD or YouTube for anyone to see the full story of what happened without clever and manipulative editing. Since we have a belief in complete openness, we have presented this material in such a manner. Anyone who sincerely wishes to find out what actually happened at any of our past presentations need

only look at such material. We honour the free will of every person with whom we come into contact.

Mr Millikan and his photographer stayed in our private 2 bedroom home (what Channel 7 now calls the "compound") without charge for two days. He followed us wherever we went without limits being placed upon him aside from requesting that we were given a copy of all footage and recordings in their raw format. Although he initially verbally agreed to do this, he has not supplied all of what has been recorded. Mr Millikan and his photographer were given complete unrestricted access to our home. They slept in our home while we stayed in a tent on our property. Mary and I cooked for them, cleaned up after them, and demonstrated our openness and honesty in dealing with them. I also suggested to them that I would not take legal action against Channel 7 if they purposefully lied or misrepresented us within the presentation, a promise that Mr Millikan has now taken full advantage of. We stated this because we believe that it is loving for us to give the gift of ourselves, our time and our sincerity without concern about whether others misuse that gift. How people respond to gifts given to them is a measure of their own development in love.

Unfortunately, it appears that many persons do sincerely believe that the media generally presents the truth, because Mary and I do receive abusive emails and phone calls as a result of the inaccurate media portrayal. I feel compassion and concern for these people, since they believe that the media portrays the truth when it has been our experience that it generally does not, and it is difficult to respond in any detail to concerns they have which are simply not based on any truth, and are just the results of media misinformation.

The only thing I can see that the media has said that is the actual truth is that I am claiming to be Jesus. However, they erroneously add that I am claiming to be God, which I disagree with completely. I am a child of God, just as everyone else on the planet is.

Aside from that, very little truth has been presented. If what the media said was completely true, then we could understand people's concern. However, what the media portrays is not the truth, and, rather than being a representation of the Divine Truth that Mary and myself present, or an unbiased report of the truth about our lives and the lives of those who listen to us, it is unfortunately the result of direct efforts of some reporters, editors, and producers to falsify the truth in order to backup their own personal opinions and belief systems, and to make money out of my claim of being Jesus.

When the media is capable of intelligent questioning without sensationalism, is able to truthfully represent my answers to intelligent questions, is able to present video and words in context, is able to sincerely desire to present truthfully what actually happens, and is able to respect the free will of others, then we shall find out the real truth, and also the public will find out that they have been misled in regards to these stories.

Unfortunately, those members of the media who are claiming that I am deceitful, a liar, manipulative, a destroyer of families, a controller of people, and other such false claims, and imply that Mary is manipulated, deceived and emotionally unstable, are, through their own lies and manipulations of the truth, demonstrating that they themselves are generally what they accuse us of being.
